



Health and safety policy

This policy will be reviewed on an annual basis

Statement of intent

We promote the good health of the children and take necessary steps to prevent the spread of infection and take appropriate action when they arise.

This setting believes that the health and safety of children is of paramount importance.

We make our setting a safe and healthy place for children, parents, early years educators and volunteers.

Aim

We aim to make children, parents and staff aware of health and safety issues and to minimise the hazards and risks to enable the children to thrive in a healthy and safe environment.

Methods

The trustee member responsible for health and safety is **Nigel Cooper**. The early years educator responsible for health and safety is **Michelle Dymond**; both are competent to carry out these responsibilities. Both have undertaken health and safety training and regularly updates her knowledge and understanding. We display the HSE Health and Safety poster on the kitchen door.

Risk assessment

Our risk assessment process covers adults and children and includes:

Checking for hazards and risks indoors and outside, risk assessing activities and procedures.

Record any hazards and act upon them immediately or draw up an action plan.

We complete a health and safety checklist daily before the session begins

Annually - when a full risk assessment is carried out.

Insurance cover

We have public liability insurance and employers' liability insurance. The certificate for public liability insurance is displayed on the parents' fold-out notice board in the Hall.

Awareness rising

Our induction training for playworkers and volunteers emphasises the importance of the health and safety at work act 1974 etc. Covers HACCP, COSH and general well-being.

Records are kept and signed.

Health and safety training is included in the settings annual training plan.

We have a no smoking policy.

Children are made aware of health and safety issues through discussions, planned activities and routines.

Children's safety

We ensure all employed playworkers and regular volunteers undertake an enhanced disclosure baring scheme.

All children are indirectly supervised or supervised appropriately by playworkers
Whenever children are on the premises at least two adults must be present.

Security

Systems are in place for the safe arrival and departure of children and adults. The times of the adults or children's arrivals and departures are recorded.

Our systems prevent unauthorised access to our premises.

Our systems prevent children from leaving our premises unnoticed.

The personal possessions of playworkers and volunteers are securely stored in lockers or left at their own personal risk inside the building.

Windows/Doors/Floors

Low level windows are made from materials that prevent accidental breakage

We apply door stoppers or latch doors open as a precaution to prevent children's fingers from being trapped.

Fire doors have magnetic locks which automatically close if the alarm is sounded.

All surfaces are checked daily to ensure they are clean and not uneven or damaged.

Kitchen

Children do not have unsupervised access to the kitchen.

All surfaces are clean and non-porous.

There are separate facilities for hand-washing and for washing up.

Cleaning materials and other dangerous materials are stored in a child-locked cupboard.

When children take part in cooking activities, they:

- are supervised at all times;
- are kept away from hot surfaces and hot water; and
- Do not have unsupervised access to electrical equipment.

Electrical/gas equipment

All electrical/gas equipment conforms to safety requirements and is checked regularly.

Our boiler/electrical switchgear/meter cupboard is not accessible to the children.

Fires, heaters, electric sockets, wires and leads are properly guarded and the children are taught not to touch them.

There are sufficient sockets to prevent overloading.

The temperature of hot water is controlled to prevent scalds.

Lighting and ventilation is adequate in all areas including storage areas.

Storage

All resources and materials from which children select are stored safely.

All equipment and resources are stored or stacked safely to prevent them accidentally falling or collapsing.

If items are stored out of reach (above head height) then the appropriate aid must be used for example a stool, steps or step ladder.

Outdoor area

Our outdoor area is securely fenced.

Our outdoor area is checked for safety and cleared of rubbish before it is used.

Adults and children are alerted to the dangers of poisonous plants, herbicides and pesticides.

Where water can form a pool on equipment, it is emptied before children start playing outside.

Our outdoor sand pit is covered when not in use and is cleaned regularly.

All outdoor activities are supervised at all times.

Hygiene

We regularly seek information from the Environmental Health Department and the Health Authority to ensure that we keep up to date with the latest recommendations.

Our daily routines encourage the children to learn about personal hygiene.

The setting and toilets will be regularly checked for cleanliness. We regularly clean resources and equipment, dressing-up clothes and furnishings.

We have a schedule for cleaning resources and equipment, dressing-up clothes and furnishings.

The toilet area has a high standard of hygiene including hand washing and drying facilities.

We implement good hygiene practices by:

- cleaning tables between activities;
- checking toilets regularly;
- wearing protective clothing - such as aprons and disposable gloves - as appropriate;
- providing sets of clean clothes;
- Providing tissues, wipes and paper towels.

Activities

Before purchase or loan, equipment and resources are checked to ensure that they are safe for the ages and stages of the children currently attending the setting.

The layout of play equipment allows adults and children to move safely and freely between activities.

All equipment is regularly checked for cleanliness and safety and any dangerous items are repaired or discarded.

All materials - including paint and glue - are non-toxic.

Sand is clean and suitable for children's play.

Physical play is constantly supervised.

Children are taught to handle and store tools safely.

Children who are sleeping are checked regularly.

Children learn about health, safety and personal hygiene through the activities we provide and the routines we follow.

Food and drink

Playworkers who prepare and handle food receive appropriate training and understand - and comply with - food safety and hygiene regulations.

All food and drink is stored appropriately.

Adults display extreme caution and care when carrying hot drinks through the play area(s) and do not place hot drinks within reach of children.

Snack and meal times are appropriately supervised and children do not walk about with food and drinks.

Fresh drinking water is available to the children at all times.

We operate systems to ensure that children do not have access to food/drinks to which they are allergic.

Outings and visits

We have agreed procedures for the safe conduct of outings.

Parents sign a general consent on registration for their children to be taken out as a part of the daily activities of the setting.

Parents always sign consent forms before major outings.

A risk assessment is carried out before an outing takes place.

Our adult to child ratio is high, normally one adult to two children.

Named children are assigned to individual staff to ensure each child is individually supervised and to ensure no child gets lost and that there is no unauthorised access to children.

Outings are recorded stating:

- the date and item of outing
- the venue and mode of transport
- names of staff assigned to named children
- time of return

Playworkers take a mobile phone on outings, and supplies of tissues, wipes, pants etc as well as a mini first aid pack, a snack and water. The amount of equipment will vary and be consistent with the venue and the number of children as well as how long they will be out for.

Records are kept of the vehicles used to transport children, with named drivers and appropriate insurance cover.

A minimum of two playworkers should accompany children on outings and a minimum of two should remain behind with the rest of the children.

Missing child

If a child goes missing from the setting

The person in charge will carry out a thorough search of the building and garden.

The register is checked to make sure no other child has also gone astray.

Doors and gates are checked to see if there has been a breach of security whereby a child could wander out.

Person in charge talks to early years educators to establish what happened.

If the child is not found the parent is contacted and the missing child is reported to the police.

If a child goes missing from an outing where parents are not attending and responsible for their own child, the setting ensures that there is a procedure that is followed.

As soon as it is noticed that a child is missing, playworkers on the outing ask children to stand with their designated person and carry out a headcount to ensure that no other child has gone astray. One playworker searches the immediate vicinity but does not search beyond that.

The person in charge is informed, if s/he is not on the outing and makes his/her way to the venue to aid the search and be the point of contact for the police as well as support staff.

Playworkers take the remaining children back to the setting.

The person in charge of the setting contacts the child's parent who makes their way to the setting or outing venue as agreed with the person in charge.

The playworker contacts the police using the mobile phone and report the child as missing.

In an indoor venue, the early years educators contact the venue's security who will handle the search and contact the police if the child is not found.

The person in charge contacts the chairperson of the management trustee directors who comes down to the setting as soon as possible.

The investigation

- The management trustee director carries out a full investigation taking written statements from all the playworkers present at the time, or who were on the outing.
- The key person/ early years educator writes an incident report detailing:
 - the date and time of the report;
 - what playworkers/children were in the group/outing;
 - when the child was last seen in the group/outing;
 - what has taken place in the group/outing since then; and
 - the time it is estimated that the child went missing.

A conclusion is drawn as to how the breach of security happened.

If the incident warrants a police investigation all playworkers co-operate fully. In this case, the police will handle all aspects of the investigation, including interviewing early years educators. Social Services may be involved if it seems likely that there is a child protection issue to address.

The incident is reported under RIDDOR arrangements and is recorded in the incident book; the local authority health and safety officer may want to investigate and will decide if there is a case for prosecution.

OFSTED is informed.

The Insurance Department at the Pre-School Learning Alliance is informed.

Animals

Animals visiting the setting are free from disease and safe to be with children, and do not pose a health risk.

Our setting's pets are free from disease, safe to be with children, and do not pose a health risk.

Children wash their hands after contact with animals.

Outdoor footwear worn to visit farms is cleaned of mud and debris and should not be worn indoors.

Fire safety

Fire doors are clearly marked, never obstructed and easily opened from inside.

Smoke detectors/alarms and firefighting appliances conform to BSEN standards, are fitted in appropriate high-risk areas of the building and are checked as specified by the manufacturer.

Our emergency evacuation procedures are approved by the Fire Safety Officer and are:

- clearly displayed in the premises;
- explained to new playworkers, volunteers and parents; and
- Practised regularly at least termly.

Records are kept of fire drills and the servicing of fire safety equipment.

First aid and medication

At least one playworkers with current first aid training is on the premises or on an outing at any one time. The first aid qualification includes first aid training for infants and young children.

Our first aid kit:

Complies with the Health and Safety (First Aid) Regulations 1981;

Is regularly checked by a designated member of staff and re-stocked as necessary;

Is easily accessible to adults; and

Is kept out of the reach of children.

At the time of admission to the setting, parents' written permission for emergency medical advice or treatment is sought. Parents sign and date their written approval.

Parents sign a consent form at registration allowing staff to take their child to the nearest Accident and Emergency unit to be examined, treated or admitted as necessary on the understanding that parents have been informed and are on their way to the hospital.

Our accident book:

is kept safely and accessibly;

all playworkers and volunteers know where it is kept and how to complete it; and

is reviewed at least half termly to identify any potential or actual hazards.

Ofsted is notified of any injury requiring treatment by a general practitioner or hospital doctor, or the death of a child or adult.

When there is any injury requiring general early years educator or hospital treatment to a child, parent, volunteer or visitor or where there is a death of a child or adult on the premises, we make a report to the Health and Safety Executive using the format for the Reporting of Injuries, Diseases and Dangerous Occurrences.

Dealing with incidents

We meet our legal requirements for the safety of our employees by complying with RIDDOR (the Reporting of Injury, Disease and Dangerous Occurrences Regulations). We report to the Health and Safety Executive:

any accident to playworker requiring treatment by a general practitioner or hospital; and any dangerous occurrences. This may be an event that causes injury or fatalities or an event that does not cause an accident but could have done, such as a gas leak.

Any dangerous occurrence is recorded in our Incident Book. See below.

Information for reporting the incident to Health and Safety Officer is detailed in the Pre-school Learning Alliance's publication, Accident Record.

Our Incident Folder

We keep an incident folder for recording incidents and near misses including those that that are reportable to the Health and Safety Executive as above.

These incidents include:

- calling an Ambulance for a child convulsion or serious injury.
- break in, burglary, theft of personal or the setting's property;
- fire, flood, gas leak or electrical failure;
- faults in security for example a back gate being left open or front door
- attack on a playworker or parent on the premises or nearby;
- any racist incident involving a staff or family on the centre's premises;
- any bite which has broken the skin of another child
- objects which have fallen from a height
- death of a child, and
- a terrorist attack, or threat of one.

In the incident book we record the date and time of the incident, nature of the event, who was affected, what was done about it - or if it was reported to the police, and if so a crime number. Any follow up, or insurance claim made, should also be recorded.

In the unlikely event of a terrorist attack, we follow the advice of the emergency services with regard to evacuation, medical aid and contacting children's families. Our standard Fire Safety Policy will be followed and staff will take charge of their key children. The incident is recorded when the threat is averted.

In the unlikely event of a child dying on the premises, for example, through cot death in the case of a baby, or any other means involving an older child, the emergency services are called, and the advice of these services are followed.

Administration of medication

Only prescribed medication may be administered. It must be in-date and prescribed for the current condition.

Children taking prescribed medication must be well enough to attend the setting.

Children's prescribed drugs are stored in their original containers, are clearly labelled and are inaccessible to the children.

Parents give prior written permission for the administration of medication. This states the name of the child, name/s of parent(s), date the medication starts, the name of the medication and prescribing doctor, the dose and times, or how and when the medication is to be administered.

The administration is recorded accurately each time it is given and is signed by a playworker. Parents sign the record book to acknowledge the administration of a medicine.

If the administration of prescribed medication requires medical knowledge, individual training is provided for the relevant playworker by a health professional.

Sickness

Our policy for the exclusion of ill or infectious children is discussed with parents. This includes procedures for contacting parents - or other authorised adults - if a child becomes ill while in the setting.

Parents are notified if there is an infectious disease such as chicken pox.

Children who have had sickness or diarrhoea will be excluded until 48 hours has elapsed since the last bout.

Children with headlice will be excluded, until they have been treated. Parents are asked to collect the child and other parents will be notified.

HIV (Human Immunodeficiency Virus) may affect children or families attending the setting. Early years educators will be informed about it.

Children or families are not excluded because of HIV.

Good hygiene practice concerning the clearing of any spilled bodily fluids is carried out at all times.

Playworkers suffering from sickness and diarrhoea will not work in the setting until 48 hours has elapsed since the last attack.

Ofsted is notified of any infectious diseases that a qualified medical person considers notifiable.

Safety of adults

Adults are provided with guidance about the safe storage, movement, lifting and erection of large pieces of equipment.

When adults need to reach up to store equipment or to change light bulbs, they are provided with safe equipment to do so.

All warning signs are clear and in appropriate languages.

Adults do not remain in the building on their own or leave on their own after dark.

- The sickness of early years educators and their involvement in accidents is recorded.
The records are reviewed termly to identify any issues that need to be addressed.

Records

In accordance with the Early Years Foundation Stage Welfare Requirements, we keep records of:

Adults

Names and addresses of all playworkers on the premises, including temporary playworkers who work with the children or have substantial access to them.

- names and addresses of the owners or of all members of the management trustee directors
- All records relating to the staff's employment with the setting, including application forms, references, and results of checks undertaken etc.

Children

- names, addresses and telephone numbers of parents and adults authorised to collect children from setting;
- the names, addresses and telephone numbers of emergency contacts in case of children's illness or accident;
- the allergies, dietary requirements and illnesses of individual children;
- the times of attendance of children, early years educators, volunteers and visitors;
- accidents and medicine administration records;
- Consents for outings, administration of medication, emergency treatment; and incidents.

In addition, the following procedures and documentation in relation to health and safety are in place in the Early Years Foundation Stage Statutory guidance:

Risk assessment.

Record of visitors.

Fire safety procedures.

Fire safety records and certificates.

Operational procedures for outings.

Medication and consent prior to administering.

Prior parental consent to administer medicine.

Record of the administration of medicines.

Prior parental consent for emergency treatment.

Accident record.

Sick children.

Food and drink

No smoking.
